2	Concrete – pour concrete per the drawing specifications and install (5) granite plaques
3	Canopy Structures – Engineering, Fabrication, and Installation of (2) Canopies

Bidders may bid on one or more packages. Bidder are responsible for providing all components of package(s) on which they are awarded the bid. Bids should be mailed or dropped off at City Hall, 945 S. Dettloff Drive, Arcadia, WI 54612.

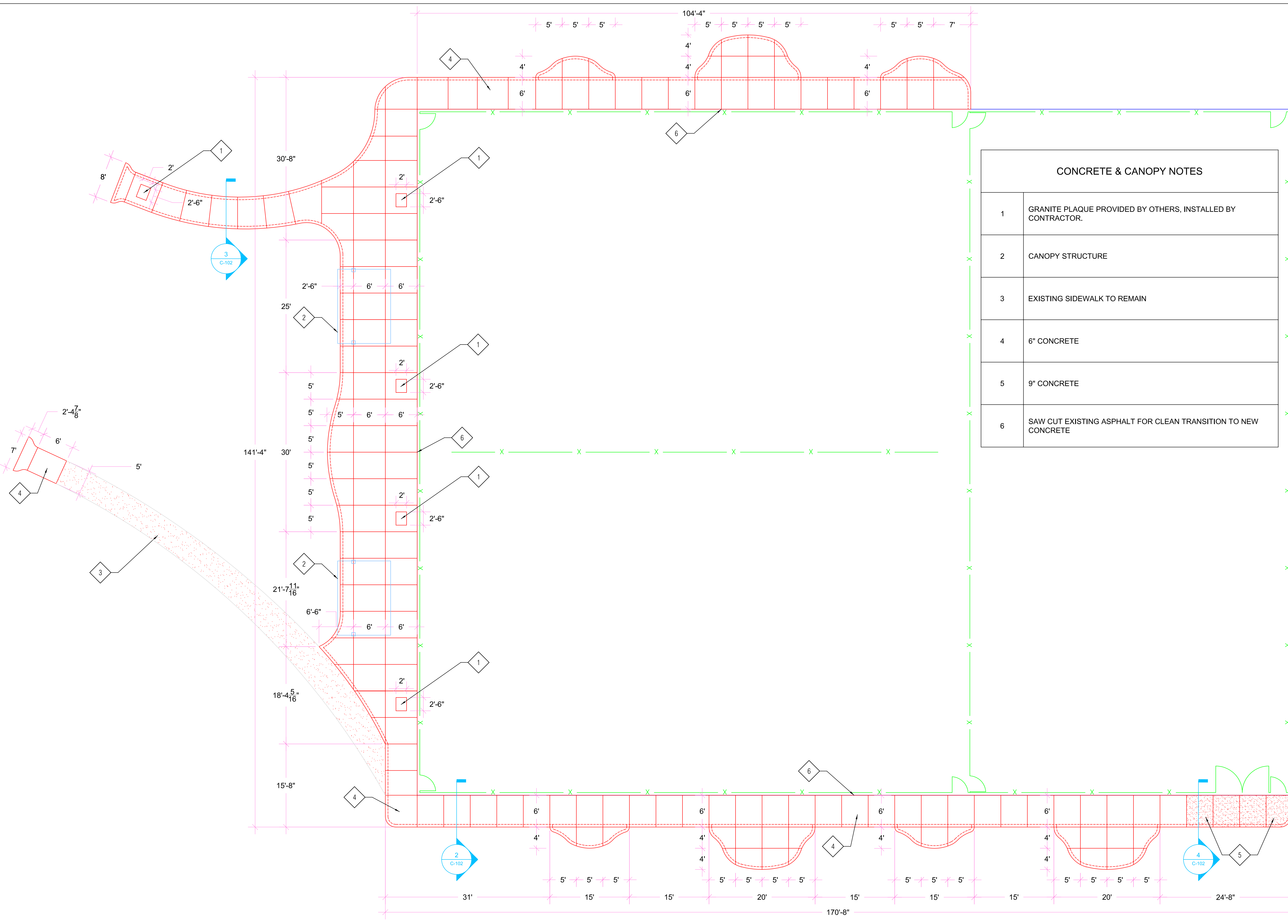

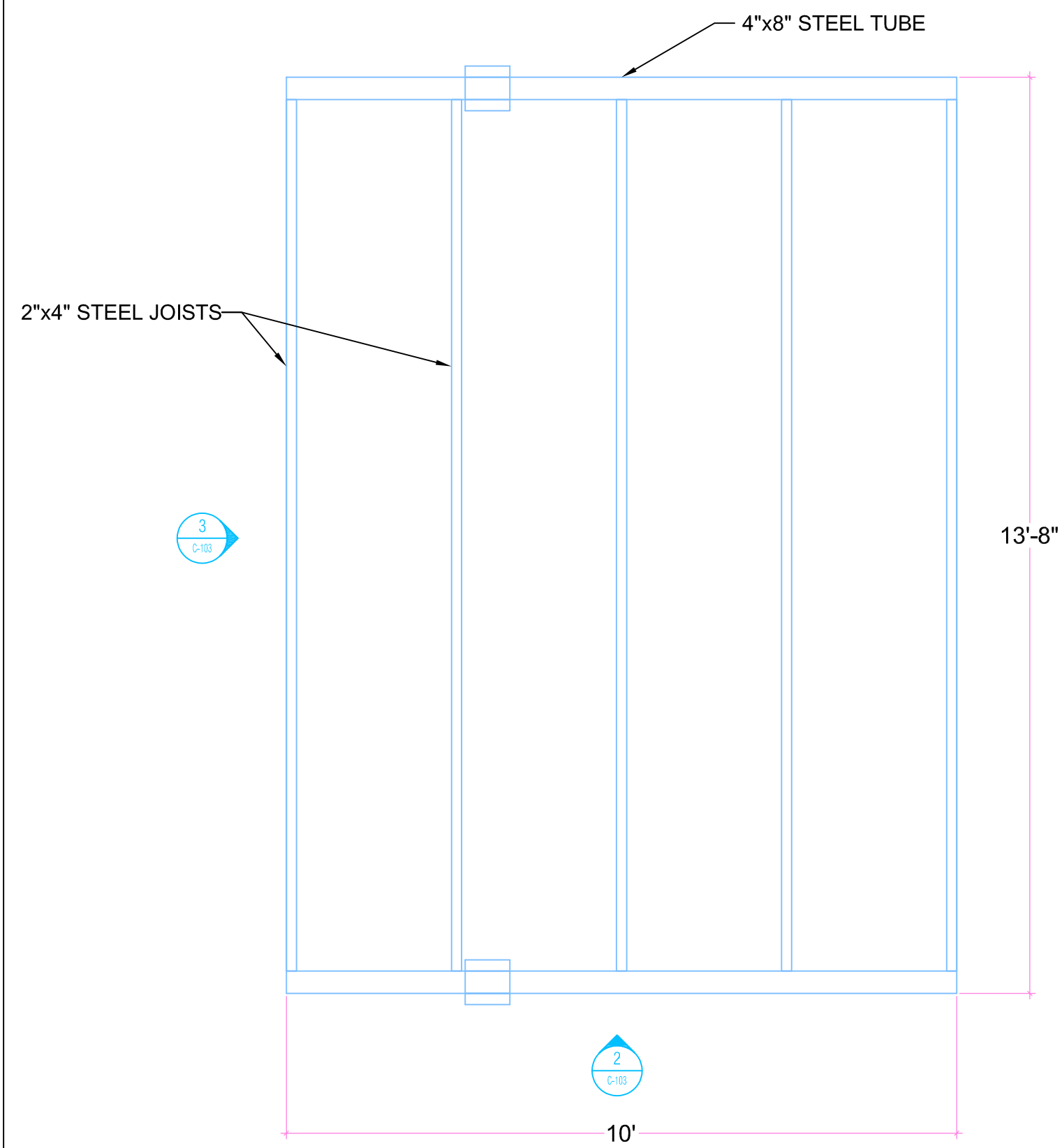

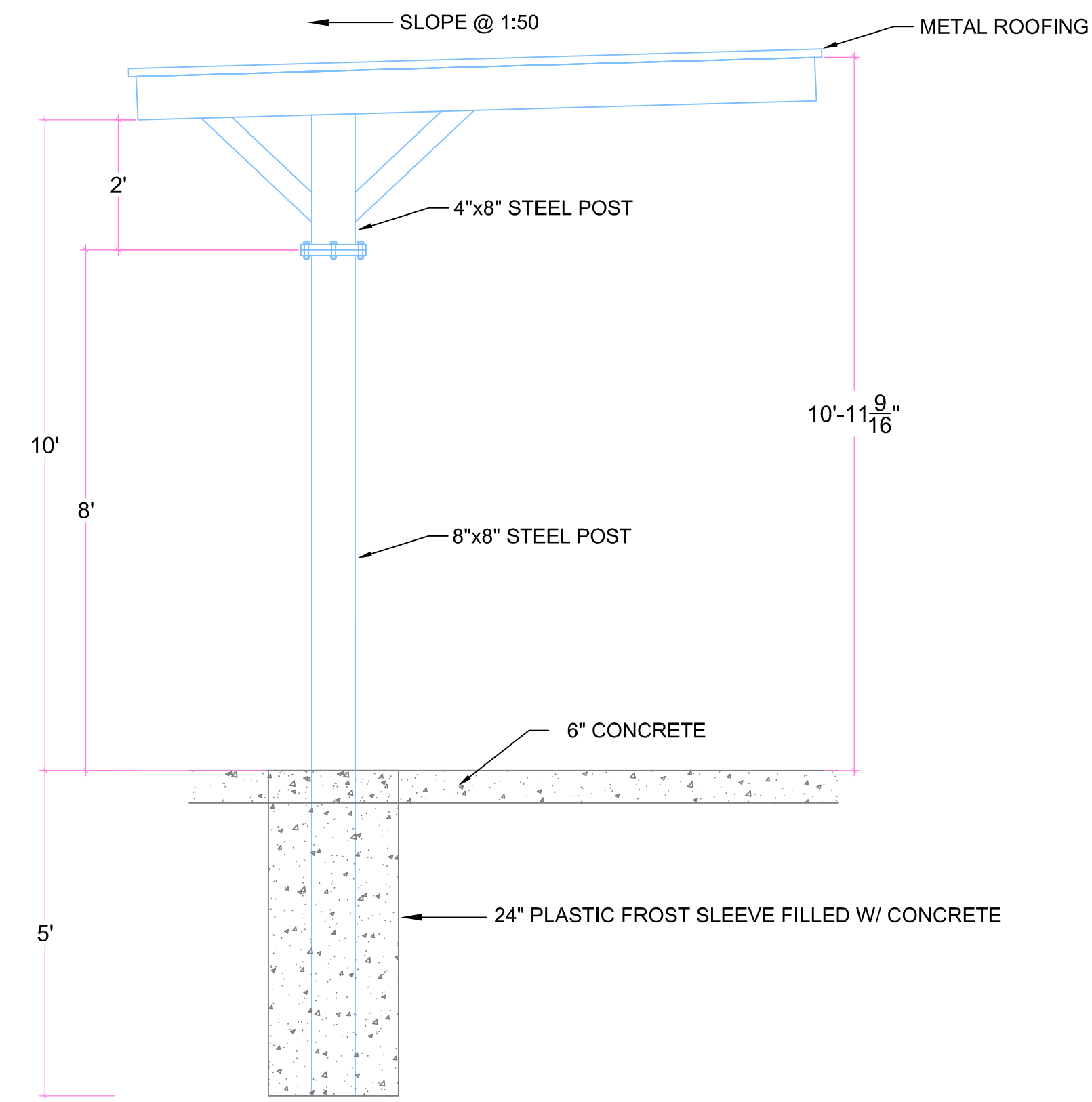

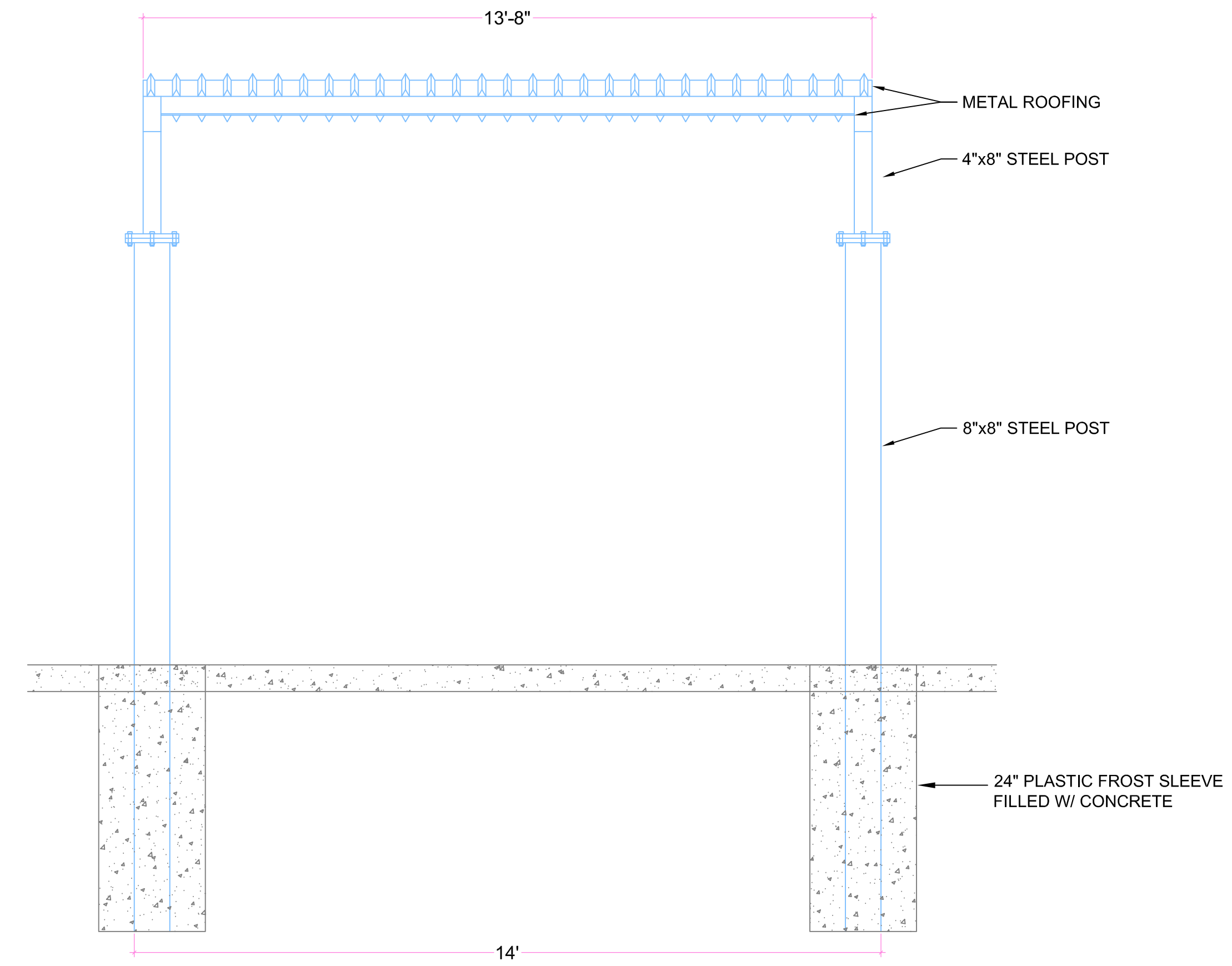
