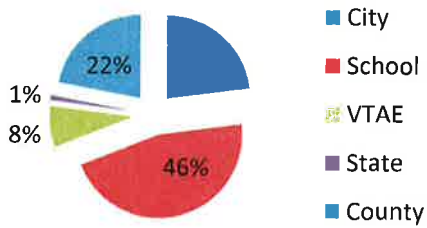

NOTICE TO CITY OF ARCADIA TAXPAYERS:

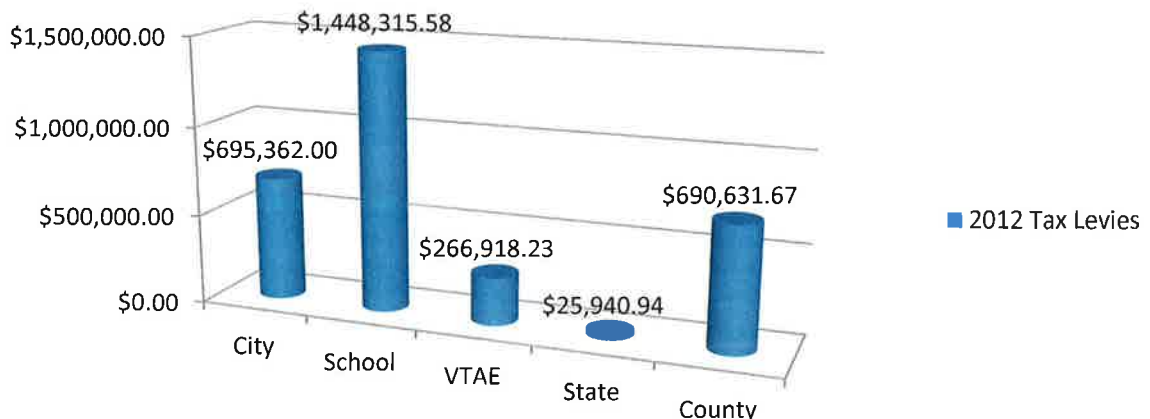
The first tax payment is to be made to the City Treasurer at 203 West Main Street, Arcadia, WI 54612. If you wish to use the installment method for paying your Real Estate Taxes, you must make the first payment to the City Treasurer by January 31, 2013. The final payment must be received by the County Treasurer no later than July 31, 2013. Personal Property Taxes and Special Assessments are due in full by January 31, 2013. All taxes and special assessments not paid by their respective due dates become delinquent and are subject to interest.

City Hall office hours are Monday – Friday from 8:00 am to 4:30 pm. You may make your payment in person during our office hours or mail your payment to us. If you would like a receipt, you must send a self-addressed, stamped envelope along with your request. Please call Angela Berg at 608-323-3359 (ext. 21) if you have questions regarding your tax bill.

ATTENTION DOG OWNERS:

The owner of a dog more than 5 months of age as of January 1 must obtain a dog license. Please bring proof of rabies vaccination with to obtain your dog license. Fees for dog licenses are \$3.00 for a spayed or neutered dog, \$8.00 for an un-neutered male or un-spayed female. Dog licenses are available at City Hall year-round.
